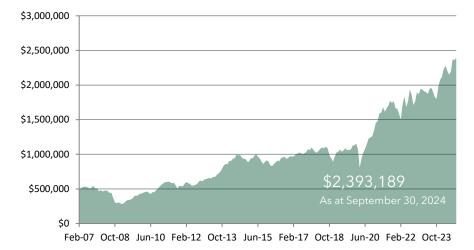

The investment analysis of this fund follows a bottom-up approach, which emphasizes careful company-specific analysis.

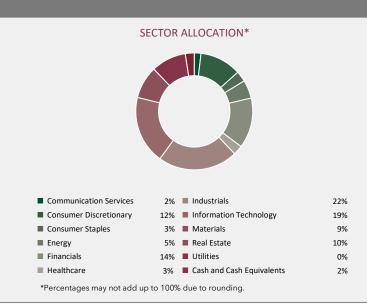
