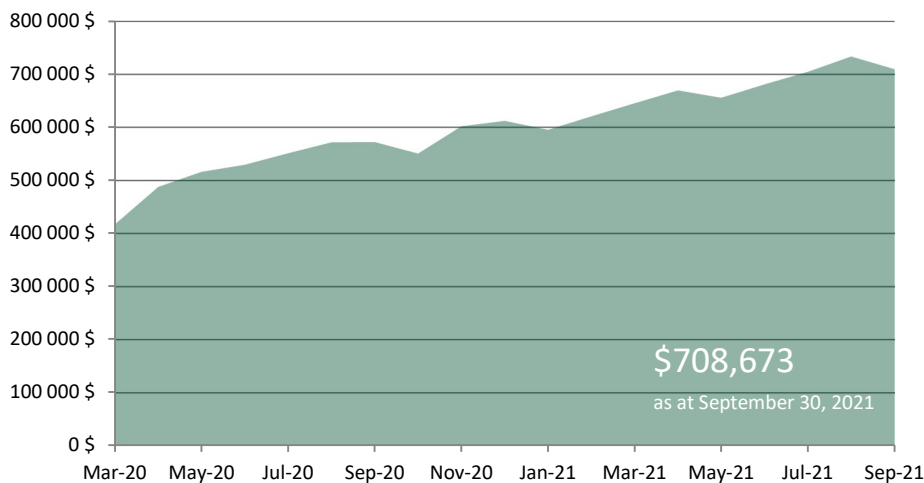

Investment Objective & Strategies

The Pembroke Canadian All Cap Pooled Fund seeks to provide investors with long-term capital appreciation primarily through investments in a portfolio of common shares and other equity securities of predominantly mid to large capitalization issuers, listed on a recognized exchange in Canada and/or the United States, that exhibit prospects for above average long-term earnings growth. The Fund may also invest in high grade short-term interest-bearing securities and Exchange Traded Funds (ETFs).

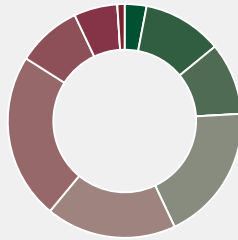
